Resolutions: 1) It is resolved to ratified and approve the minutes of the Undergraduate and Postgraduate Board of Studies for the academic year 2019-20 held from 03-05-2019 to 13-9-2019. The college Academic Council reviewed the Board of Studies proceedings.

 - 7) It is resolved to ratify the syllabi, question paper pattern, course structure and panel of examiners I semester B. Vocational with Commercial Aquaculture w.e.f. 2019-20.
 - 8) It is resolved to approve all the admissions made for I year degree courses for the academic year 2019-20. (List enclosed).
 - 9) It is resolved to adopt/implement the Choice Based Credit System (CBCS) w.e.f. the present academic year 2019-20 for all Postgraduate Courses.
 - a) It is resolved that the examination system would be 75 marks for Semester end examination and 25 marks for internal assessment. The internal assessment evaluation would be follows:
 - Two written Mid Examinations should be conducted for fifteen marks each and the average of both written examinations will be awarded.
 - Five marks for Seminar/Assignment etc.,
 - Swachhata Activity
 - b) It is resolved to adopt the Question Paper structure as follows: Section A and Section B. The Section A consists of four Questions, one Question from each unit of the syllabus with internal choice, A or B i.e. 4 X 15 = 60 Marks and Section B consists of eight questions, from which any five Questions should be answered. Each Question carries three marks i.e. 5 X 3 = 15 Marks.
 - c) A minimum qualification for appointment of Internal Examiner/External Examiner is minimum 3 years of service for practical examinations.
 - d) Single valuation system is followed for PG courses.
 - e) The student is declared to have passed in a semester if he/she secures at least 50% in aggregate in all papers put together for all PG programmes.

The student shall be declared to have passed the Semester Examination unless' he/she obtains not less than 40% marks in semester end examination (i.e.30 out of 75 marks) and 40% marks in the aggregate of semester end examination and internal assessment put together (i.e. 40 out of 100 marks) for all PG programmes.

The student is declared to have passed in a practical subject if he/she secures at least 50% in aggregate (i.e. marks in continuous internal assessment and marks in semester-end examination taken together) in Practical / Project work/ Comprehensive viva-voce for all PG programmes.

- 10) It is resolved the the following Grafting and Grace rules be adopted and implemented to all UG, PG and PG Professional Courses (M.B.A., M.C.A.,) w.e.f. 2019-20 admitted batch.
 - (i) 1% of the maximum marks (Excluding Practical Marks) of that Semester can be added for Graft by taking them from other theory subjects in which student got highest marks starting from highest to least.
 - (ii) Also after above Grafting. 1% of the maximum marks be given for Grace if necessary for passing Theory Subjects.
 - (iii) Graft/Grace marks shall be given to the students who can clear entire Semester with them.
 - (iv) The student has to clear all Practicals/Projects/ for applying Grafting/Grace.
 - (v) The students has to secure 75% of Min. Pass mark in failed subject in Semester end examinations to apply grafting and then Grace marks.

There is a provision for the students who appeared for their final year regular examinations and those who have failed in only one subject in III semester or one subject in IV semester or one subject in each III & IV Semester for 2 years course, those who have failed in only one subject in V semester or one subject in VI semester or one subject in each V & VI Semester for 3 years course are eligible for instant examination.

> No revaluation/challenge valuation for Instant Examination.

Betterment:

There is a provision for the students who appeared for their final year regular examinations and those who have failed in only one subject in III semester or one subject in IV semester or one subject in each III & IV Semester for 2 years course, those who have failed in only one subject in V semester or one subject in VI semester or one subject in each V & VI Semester for 3 years course are eligible for instant examination.

- > No revaluation/challenge valuation for betterment.
- 14) It is resolved to conduct Semester End Examinations with immediate regular Semester End Examinations who seek prior permission from the Principal
