# Academic Regulations for UG & PG Programmes

Regulations governing the Choice Based Credit System (Semester Scheme) in the Undergraduate & Post Graduate in the Faculties of Science and Commerce.

New challenges in higher education have led to a paradigm shift in reconceptualising this sector in terms of what constitutes Higher Education and what the goals of this education ought to be. Traditional educational systems rely on information based knowledge. However the shortcomings in collapsing the task of knowledge acquisition to largely an exercise in imparting information are increasingly felt in society with profound consequences. The need of the hour is to move towards a more holistic approach that integrates providing of skills and specialized training with the values necessary to make a student into a better human being and a useful member of society. Thus the role of Universities and colleges in the 21<sup>st</sup> Century extends far beyond traditional knowledge creation and dissemination to encompass new expectations for innovations that will have broader social and economic benefits. V.S.M. College wishes to initiate qualitative and substantial changes in its programmes, to cater to the needs of students with diverse talents, aspirations and professional requirements. It wishes bring in flexibility into system by allowing degrees.

The Restructured Choice Based Credit System makes the product of V.S.M. College on par with the global practices in terms of academic standards and evaluation strategies, retaining the structures of the present undergraduate programmes. In the emerging scenario of is imperative Education, it Higher of Indian Internationalization Universities/Institutions in India should follow this system so that the mobility of their products both within and across the geographical jurisdiction becomes possible. Hence the V.S.M. College thought it fit to introduce Choice Based Credit System in all the Undergraduate & post graduate Programmes in the Faculties of Arts, Science and Commerce, effective from the academic year 2015-16. For multifaceted development of students, curriculum emphasizes on wide variety of programmes to enhance their knowledge in several core programmes including those in languages and subjects in Arts, Science and Commerce, and value-based and skill development programmes.

The University Grants Commission has asked all the universities/institutions in the country to implement the Choice Based Credit System (CBCS) in all the under-graduate and postgraduate programmes. The State Higher Education Council has also communicated general guidelines in this regard.

# 1. Choice Based Credit System coupled with grading, an innovative method of curriculum design and evaluation:

- 1.1) A credit is a numerical weightage given to a programme depending on the depth of the teaching learning process. A course is a paper prescribed in the curriculum of a programme.
- 1.2) On passing a programme, the student will earn the credits assigned to it. Credits shall be counted as "weights" for calculating the Cumulative Grade Point Average (CGPA).

1.3) The Academic Council shall allocate credits for different parts of an undergraduate programme and for their constituent subjects. The Academic Council shall be chaired by the Principal and shall include, Heads of the departments, Controller of Examinations, Four teachers of the college representing different categories of senior teaching staff in the college, four experts/academicians from outside the college representing such areas as Industry, Commerce, Law, Education, Medicine, Engineering, Sciences etc., to be nominated by the Governing Body, Three nominees of the university not less than Professors, a faculty member nominated by the Principal (Member Secretary). Credits for different programmes of a subject shall be recommended by the respective Boards of Studies, subject to the approval of the Academic Council.

#### 2. SCOPE AND COMMENCEMENT:

- a) These regulations shall be called "The Regulations Governing the Choice Based Credit System (Semester Scheme) in the Undergraduate and Postgraduate in the Faculties of Science and Commerce".
- b) These Guidelines of Curricular Framework with revised Choice Based Credit System comes into effect from the academic year 2020 2021, to be strictly adhered for all Undergraduate Programmes.
- c) The regulations of adopting CBCS and the allotment of teaching hours per paper were all approved in the Academic Council of 2020-21.

#### 2.1 SCOPE:

- a) The regulations provided herein shall apply to all regular Undergraduate and Postgraduate Programmes offered by all the Faculties of VSM College.
- b) These regulations are quite comprehensive and include definitions of key terms, critical concepts, and mechanics of calculations, role of various boards and committees and the evaluation system.

#### **2.2 COMMENCEMENT:**

- a) These regulations came into force with effect from the admissions commencing from 2020-21 & onwards.
- b) Provisions under these regulations hereby supersede all the existing regulations for the regular UG& PG programmes of VSM College to the extent prescribed herein.



#### 3. DURATION:

The academic year shall comprise of two semester viz. Odd and Even semesters. Odd semesters shall be from June / July to October / November and Even Semesters shall be from November / December to April / May. Each semester shall have normally consists of minimum 90 instructional days. There shall be a minimum of 30 hours maximum of 36 hours of teaching per week excluding the assessment hours.

#### 5. ADMISSION PROCEDURE AND ELIGIBILITY

#### **UG Programmes:**

> From this academic year, 2020-21 all the admissions are conducted in online mode.

- ➤ The notification for issue and receipt of applications for admission into UG Programmes shall be notified in the college notice board and in the local newspapers.
- Admissions are made on the basis of merit at the qualifying examination and following the rules of reservation as prescribed by the Govt. of Andhra Pradesh from time to time.
- ➤ The 'Admissions Committee' Constituted by the Principal for the purpose shall make the admissions for UG programmes.

#### 5.1 Bachelor of Science (B.Sc.):

Candidates for the Degree of Bachelor of Science (B.Sc.) shall be required:

(i) For admission into I semester of B.Sc. (MPC) and B.Sc. (MPCS), the candidate should have passed the Intermediate Examination of B.I.E., A.P. with Mathematics, Physics and Chemistry as optional subjects or any other equivalent Examination.

(ii) For admission into I semester of B.Sc. (BZC) and B.Sc. (AZC), the candidate should have passed the Intermediate Examination of B.I.E., A.P. with Biological Sciences, Physics & Chemistry as optional subjects or any other equivalent Examination.

#### 5.2 Bachelor of Vocational (B. Voc.)

Candidates for the Degree of Bachelor of Vocational (B. Voc.) shall be required:

For admission into I semester of B. Voc. the candidate should have passed 10+2 examination or equivalent, in any stream without any background of vocational training. These programmes have multiple entries and multiple exits.

#### 5.3 Bachelor of Commerce (B.Com.):

Candidates for the Degree of Bachelor of Commerce (B.Com.) shall be required: For admission into I semester of B.Com. (General), B.Com. (Computer Applications), the candidate should have passed the Intermediate Examination of B.I.E., A.P. or any other equivalent Examination. Weightage may be given to the candidates who have passed with CEC and MEC Combination.

#### 5.4 Bachelor of Business Administration (B.B.A):

Candidates for the Degree of Bachelor of Business Administration (B.B.A.) shall be required: For admission into I semester of B.B.A., the candidate should have passed the two year Intermediate Examination conducted by the Board of Intermediate Education in Andhra Pradesh or any equivalent examination recognized by the Board of Intermediate Examination or 10+2 examination recognized by the Academic Senate as equivalent thereto;

#### 5.5 Bachelor of Computer Applications (B.C.A):

Candidates for the Degree of Bachelor of Computer Applications (B.C.A) shall be required: For admission into I semester of B.C.A., the candidate should have passed the two year Intermediate Examination (any combination including vocational) conducted by the Board of Intermediate Education, in Andhra Pradesh or any equivalent examination recognized by the Board of Intermediate Examination or +2 examination recognized by the Academic Senate as equivalent thereto;

(i) Diploma (3 years/3½years) passed students be given admission on lateral entry into II-year of B.Com. - (ii) In case of Intermediate Vocational and other diploma holders, stipulations of Bridge Programmes existing to be followed in admissions for UG Programmes. The eligibility criteria for admissions for the above such programmes are attached herewith as **Annexure I.**

#### **PG Programmes:**

- counselling by the Convener, ICET on the basis of rank obtained in ICET (Integrated Common Entrance Test) Exam conducted by Govt. of A.P. and as per guidelines given by APSCHE from time to time.
- ➤ The candidate seeking admission into M.B.A. programme shall have passed the prescribed qualifying Examination with not less than 50% of the marks in aggregate of all the years /semesters of the Bachelor's Degree (other than B.F.A. & B.A., Oriental Languages) of any recognized University.
- The candidate seeking admission in to M.C.A. programme should have passed a Bachelor's Degree examination of not less than three years duration in any discipline with mathematics at 10+2 level or should have passed Bachelor's Degree Examination of not less than three years duration in any discipline with mathematics as one of the subjects, are eligible for direct admission into MCA through ICET
- ➤ Students are admitted into M.Sc. through central counselling by the Convener, AKNU on the basis of rank obtained in AKNUCET (Adikavi Nannaya University Common Entrance Test) conducted by Adikavi Nannaya University, Rajamahendravaram.

#### 6. Courses in Programmes:

The UG programme consists of number courses. The term "course" is applied to indicate a logical part of the subject matter of the programme and is invariably equivalent to the subject matter of a "paper" in the conventional sense. #### 6.1 From the Admitted Batch 2020-2021:

There is an Introduction of skill-oriented courses to align with the emerging and employment areas. The curricular framework was revised and updated for UG Programmes intended for B.Com., B.Sc., BCA, BBA, UG Honours, under CBCS pattern from the year 2020-21.

- To ensure inculcating social responsibility and compassionate commitment among the students, the summer vacation in the intervening 1st and 2nd years of study shall be for Community Service,
- FIRST and SECOND PHASES (2 spells) of APPRENTICESHIP between 1st and 2<sup>nd</sup> year and between 2<sup>nd</sup> and 3rd year (two summer vacations).
- During the entire5th/6th Semester, the student shall undergo Apprenticeship / Internship / On the Job Training.
- This is to ensure that the students develop hands on technical skills which will be of great help in facing the world of work.
- > Figures in parenthesis are hours per week of Core Courses of Science.
- In respect of Commerce Courses, the hours per week for Core Courses will be 5.
- ➤ SEC1 and SEC-2 in Semester -V are C-6 and C-7 respectively.
- **6.1.1.** Core Courses: Three core courses of Domain subjects will be in the first three semesters, and the fourth and fifth courses will be in the fourth semester. Two domain SECs will be in the fifth semester. There will be uniformly five Core Courses in each Domain Subject in BSc, and 15 in B.Com.

**6.1.4. Skill Enhancement Courses:** Two Skill Enhancement Courses will be offered for each domain subject, in Semester V. The two Skill Enhancement Courses of each domain subject will be linked for a wider basic and practical experience to students.

#### 7. FOR THE ADMITTED BATCH 2019-20

#### 7.1. Core Course:-

There may be a Core Course in every semester. This is the course which is to be compulsorily studied by a student as a core requirement to complete the requirement of a programme in a said discipline of study.

#### 7.2. Elective Course:

Generally a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline/subject of study or which provides an extended scope or which enables an exposure to some other discipline/subject/domain or nurtures the candidate's proficiency/skill is called an Elective Course. An elective may be "Generic Elective" focusing on those courses which add generic proficiency to the students. An elective may be "Discipline centric" or may be chosen from an unrelated discipline. It may be called an "Open Elective."

#### a. Discipline Specific Elective (DSE) Course:

Elective courses may be offered by the main discipline/subject of study is referred to as Discipline Specific Elective. The University/Institute may also offer discipline related Elective courses of interdisciplinary nature (to be offered by main discipline/subject of study).

#### b. Dissertation/Project:

An elective course designed to acquire special/advanced knowledge, such as supplement study/support study to a project work, and a candidate study such a course on his own with an advisory support by a teacher/faculty member is called dissertation/project.

#### c. Generic Elective (GE) Course:

An elective course chosen generally from an unrelated discipline/subject, with an intention to seek exposure is called a Generic Elective.

#### d. Foundation Courses (FC):

As a part of curriculum up gradation, Semester and CBCS systems were introduced from 2015-16. As an effective part of the overall curriculum, Foundation Courses were introduced with an aim to prepare students in the required basic skills and values in diverse areas. Hence, courses covering a broad spectrum were introduced. The following are the revised syllabi of the six Foundation Courses, each

with 30 teaching hours per semester and worth 2 credits. They were spread in the 3rd and 4<sup>th</sup> Semesters.

#### 9. BOARDS OF STUDIES, COURSES & SYLLABI:

- a. The Academic Council on the recommendation of the concerned Faculty shall prescribe the various courses in the respective discipline, subject to the general regulations of the University/Institution.
- b. The Boards of Studies shall prepare the syllabi of each course shall be prepared module-wise and include the Course Code, course title, objectives, learning out comes, module wise content, credits assigned, prescribed instructional hours, scheme of examination, model question paper, blue print and prepare panels of paper setters and recommended to the Academic Council for consideration and approval.
- c. The Academic Council shall lay down the evaluation system.

#### 10. Medium of Instruction:

#### **UG Programmes:**

The medium of instruction and examination shall be English or Telugu

#### **PG Programmes:**

The medium of instruction and examination shall be English only.

#### 11. Credits:

#### 11.1. The minimum required credits for UG Programmes:

(Annexure – II) For B. Voc Programme the minimum total number of credits in General education is a total of 72 and with Skill Component it is 108 for III years.

#### 11.2.1.1 . The minimum required credits for PG Programmes:

 For all 2-year PG Science programmes with 4 semesters i.e., each semester minimum 16 credits are allotted to theory papers and minimum 8 credits for practical papers.

#### 13. Change of Programme / Language / Course:

In UG programmes, an option to change a language/programme may be exercised only once within two weeks from the date of commencement of the I Semester.

In the PG courses regarding Chemistry the ANALYTICAL & ORGANIC both has the same syllabus in I& II Semesters. If any of the candidates want to have a change in the course in the second year (Semester – III) there is a provision to change basing on mutual grounds. Prior approval for change of the course has to be obtained from the Legal Section, Adikavi Nannaya University, Rajamahendravaram.

#### 14. Attendance

- a) A candidate shall be considered to have satisfied the requirement of attendance for a semester if he/she attends not less than 75% of the number of classes actually held up to the end of the semester in each of the subjects.
- b) If the candidate is detained due to lack of required attendance, he/she has to repeat the course. He/she will not be permitted to the subsequent semester unless he/she complete the detained semester. Condonation for the shortage of attendance may be granted on the recommendation of the Principal of the College concerned provided, that no condonation shall be recommended in the case of candidates who have not put in attendance at the college for at least 65% of the total number of working days.

c) If a candidate represents his/her institution/University/State/ Nation in Sports/ NCC/ NSS/ Cultural or any officially sponsored activities he/she may be permitted to claim attendance for actual number of days participated, based on the recommendation of the Head of the Institution concerned. If a candidate is selected to participate in national level events such as Republic Day Parade etc., he/she may be permitted to claim attendance for actual number of days participated based on the recommendation of the nead of the Institution concerned.

- d) The Principal is authorized to condone the shortage of attendance in theory & practical courses in deserving cases, by collecting prescribed fee. However, the student should have to put in a minimum attendance of 60% in aggregate of the total number of periods worked in theory or practical courses for that programme.
- e) Any student of II VI semesters who fail to satisfy rules attendance shall be required to repeat the semester, in the next academic year. However, a student of I semester in the event of detention or discontinuation should seek fresh admission.
- f) All the students who have registered for Semester-end Examinations and satisfy rules of attendance are eligible for promotion irrespective of their Pass or Fail.

#### 15. Re-admission / Transfer of admission:

- i. The candidate who was detained earlier under old scheme of curriculum and seeking readmission/admission on transfer shall be admitted under NEWLY revised curriculum of semester schemes only. The student so admitted shall have to appear and pass the papers which are not studied, as decided by the Legal section of University.
- ii. The candidate who was detained for not putting up required percentage of attendance (i.e. 75%) in a particular semester his however eligible to seek readmission in the same semester.
- iii. The student who has put up required Percentage (%) of attendance and not applied for the examinations or not appeared for any of the papers is also eligible to seek readmission in the same semester.
- iv. The student who after completing a year of a Programme but taken TC to join some other course and, come back to continue the earlier Programme is also eligible for readmission.
- v. The student is eligible for readmission on break-up for one time only, with a maximum period of break-up for two years.
- vi. The eligible student should apply through the concerned Principal to the Dean-CDC for readmission well in advance as per the schedule released by the university, or



- getting admission as well as for getting exemption of papers or extra papers to be passed in the beginning of academic year with all marks lists, fee, TC, NOC letter from both the Principals etc.,
- vii. The readmission is to be within the stipulated period as per UGC guidelines (i.e. UGC DO No.F.12-1/2015 (CPP-II) dated 15<sup>th</sup> October 2015) for completing the Programme i.e., course period +2 years for all the courses.
- viii. In case of extra papers to be written by the readmitted/lateral entry students as per the equivalency order, the semester end exam marks obtained may be scaled up according to maximum marks, since the internal marks would not be available in those respective papers.

#### 17. Internal Assessment:

- 17.1 The examination pattern for I Year UG Programme (w.e.f.: 2020-21 admitted batch):
  - The Semester end examination is for 60 Marks and 40 marks for internal assessment.

    The internal assessment would be as follows:
  - > Two Mid Examinations (Online or Offline) should be conducted for twenty marks each and the average of both examinations will be awarded as the marks obtained in Mid Examinations.
  - > Ten marks for Project work/ Seminar +viva/Work book etc.,
  - > Ten Marks for Assignment through LMS.

#### 17.2. The examination pattern for II Year & III Year UG Programmes:

- > The Semester end examination is for 75 Marks and 25 marks for internal assessment.

  The internal assessment would be as follows:
- > Two Mid Examinations (Online / Offline) should be conducted for fifteen marks each and the average of both examinations will be considered.
- > Five marks for Assignment.
- > Five marks for Class room seminars/quiz

#### 17.3. The examination pattern for PG Programmes:

The Semester end examination is for 75 Marks and 25 marks for internal assessment.

The internal assessment would be as follows:

- > Two Mid Examinations (Online / Offline) should be conducted for fifteen marks each and the average of both examinations will be considered.
- > Five marks for Assignment/Seminars/quiz
- Five marks for Swachhata Activity.
- 17.4. The Internal assessment marks shall be communicated to the Controller of Examinations at least 15 days before the commencement of the semester end examinations.
- 17.5. There shall be no minimum pass marks percentage fixed for the internal assessment of theory and practical.
- 17.6. There is no provision to have revaluation of internal marks or to call back the marks statements issued in the earlier semesters.
- 17.7. The internal assessment should be done during the course time in the respective semester only i.e. no repetition for internal assessment of theory and practical.
- 17.8. Re-mid exam shall be conducted to the students, who seek prior permission from the Principal to attend NCC/NSS/Sports activities.

#### 18. REGISTRATION FOR EXAMINATION:

A candidate shall register for all the papers of a semester when he/she appears for the examination of that semester for the first time. The student, who has not registered for the semester shall not be permitted to attend the examinations for the next semester and he shall repeat the same semester in the next year along with his/her juniors.

#### 19. CONDUCT OF SEMESTER END EXAMINATIONS:

There shall be Theory and Practical examinations at the end of each semester, ordinarily during October/November for odd semesters and during April/May for even semesters, as prescribed in the Scheme of Examinations. A candidate who does not pass the examination in any programme(s) shall be permitted to appear in such failed programme(s) in the supplementary/subsequent examinations to be held in October / November or April / May.

- As stated in the schemes of examination, practical examinations shall be conducted at the end of each semester. The odd semester practical examinations are to be conducted with both internal examiners. The even semester practical examinations are to be conducted by two examiners, one internal and one external and shall never be conducted by both internal examiners.
- The statement of marks sheet and the answer books of practical examinations shall be sent to the Controller of Examinations through the Chief Superintendent by the respective departments immediately after completion of the practical examinations.
- The candidate shall submit the record book for practical examination duly certified by the course teacher and the H.O.D/staff in-charge. It shall be evaluated at the end of the Semester at the practical examination.



#### CONDUCT OF PRACTICAL EXAMINATIONS:

As stated in the schemes of examination, practical examinations shall be conducted at the end of each semester. External/Internal examiners should have at least three years of teaching experience in the paper. The statement of marks sheet and the answer books of practical examinations shall be sent to the Controller of Examinations through the Chief Superintendent by the respective departments immediately after completion of the practical examinations.

#### A UG Programmes:

The odd semester practical examinations are to be conducted with both internal examiners. The even semester practical examinations are to be conducted by two examiners, one internal and one external and shall never be conducted by both internal examiners.

#### B. PG Programmes

The odd and even semester end practical examinations are to be conducted by one internal and one external examiner.

#### 20. Minimum Marks for Pass:

#### 20.1. UG Programmes:

No candidate shall be declared to have passed the Semester End Examination unless he/she obtains not less than 35% marks in Semester End Examination (i.e. 21 out of 60 and 26 out of 75 marks) and 40% marks in the aggregate of semester end examination and internal assessment put together in each of the subjects (i.e. 40 out of 100 marks), 40% marks in foundation courses/Life skill courses/ Skill Development courses and practical examinations. Further, a candidate has to secure a minimum of 4.0 SGPA for a pass in each semester. A student who fails to secure over all 40% should re-appear for the external examination in the respective semester exam only.

#### 20.2. PG Programmes:

The student is declared to have passed in a Semester End Examination if he/she secures at least 50% in aggregate in all papers put together for all PG programmes.

The student shall be declared to have passed the Semester End Examination unless he/she obtains not less than 40% marks in semester end examination (i.e.30 out of 75 marks) and 40% marks in the aggregate of Semester End Examination and internal assessment put together (i.e. 40 out of 100 marks) for all PG programmes.

The student is declared to have passed in a practical subject if he/she secures at least 50% in aggregate (i.e. marks in continuous internal assessment and marks in semester-end examination taken together) in Practical / Project work/Comprehensive viva-voce for all PG programmes.

Further, a candidate has to secure a minimum of 5.0 SGPA for a pass in each semester. A failed candidate will be permitted to appear in any subject/paper to secure a minimum prescribed grade, to enable the candidate to pass at the end of any semester end examination.

#### 21. Supplementary Examinations:

There are no supplementary examinations as per UGC norms. A candidate, who fails in semester-end examinations, may take the examination in that paper in which he/she failed in the supplementary examination to be conducted along with the candidates of the subsequent batch at the regular Semester-End Examinations.

#### 22. Criteria to transmit Question Paper:

The candidate who could not complete the course with in the period prescribed will be allowed to write examinations in the respective Semester End Examination only for <u>two</u> more years with the syllabus prescribed for his/her period of study. If fails to finish the course with in this period he/ she has to write examinations following changed syllabus in existence at that time.

#### 23. Blind Candidates/ Physically Handicapped:

Candidates suffering from blindness, locomotors disability and cerebral palsy can use scribes to write examination.

Such candidates will also get compensatory time of thirty minutes per hour for the exam. They are been allowed the help of a scribe to write the answers for them.

"However, blind candidates and candidates with locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40 per cent impairment) will be allowed to write the examination with the help of a scribe.

"Low vision candidates (minimum 40 per cent impairment) will be allowed to write the examination with the help of a scribe. "Low vision candidates will also be allowed an extra time of thirty minutes for each paper.

The Chief Superintendent will appoint the scribe from among the Assistant Superintendent on duty at the time of exams. The staff member appointed, as a scribe should belong to without graduation.

#### 24. Revaluation:

The students are permitted to apply for revaluation of their answer scripts if they are not satisfied with their first valuation. The students are required to pay the prescribed amount for each paper separately in which they seek revaluation.

If the difference of marks in the original valuation and revaluation is 20% or more, the answer script shall be sent for third valuation and the average of the nearest two awarded marks shall stand.

When the exam schedule is released before the declaration of revaluation results the candidate should pay the exam fee for which he is awaiting for the revaluation.

#### 25. Challenge valuation:

A student who desires to apply for challenge valuation shall obtain a Xerox copy of the answer script by paying the prescribed fee within 10 days after the announcement of the results. He / She can challenge the grade awarded to him/her by surrendering the grade card



and by submitting an application along with the prescribed fee to the Controller of Examinations within 15 days after the announcement of the results. This challenge valuation is for all Theory papers. The answer scripts for which challenge valuation is sought for shall be sent to another external examiner. The marks awarded in the challenge valuation shall be the final.

> However, there is no provision for revaluation/challenge valuation to instant examination.

#### 26. Instant Examination:

Although the **Instant** examinations are conducted for theory papers for III year regular students, i.e. for those who appeared for VI semester examinations.

- ➤ A student can apply for **Instant** examinations for any number of theory papers of V and VI semesters with the following conditions at the time of applying for Instant Examinations.
- 1. The student ought to have passed all the subject/paper in the I year degree i.e. in I and II Semesters.
- 2. The student may be failed or absent in a maximum of one paper in each semester during the II year degree examinations i.e. during III and IV semesters.
- If the candidate does not get the revaluation result of examination, he/she should apply for the instant examinations, as soon as the exam schedule is released.

#### PG Courses:

There is a provision for the students who appeared for their final year regular examinations. Those who have failed in only **one** subject in III semester or one subject in IV semester or one subject in each III & IV Semesters for 2 years programme, are eligible for instant examination.

> No revaluation/challenge valuation for Instant Examination.

# 27. Carry Over:

A candidate either in PG or UG who was not succeed in a lower Semester Examination could pursue his/her advanced semester.

#### 28. Classification of successful candidates:

The results of successful candidates at the end of IV/VI semester shall be classified on the basis of aggregate percentage of marks obtained in all the four/six semesters and the Aggregate or Cumulative Grade Point Average (CGPA) for the award Degree in Arts, Science, Commerce and Management.

## 28.1 Letter Grade for SGPA and CGPA:

Each semester result shall also be declared in terms of grades. A ten point grading system which is based on the actual absolute marks scored and alpha – sign grade as shown below.

A student obtaining Grade F shall be considered failed and will be required to reappear in the examination.

> That the formula for CGPA conversion into marks should be fixed as CGPA X 10 as recommended by UGC.

#### 28.3. Computation of SGPA and CGPA:

Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

i. The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student,

i.e SGPA (Si) = 
$$\sum$$
 (CixGi) / $\sum$ Ci

where Ci is the number of credits of the ith course and Gi is the grade point scored by the student in the ith course.

ii. The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme,

i.e. 
$$\mathbf{CGPA} = \sum (\mathrm{Ci} \times \mathrm{Si}) / \sum \mathrm{Ci}$$

Where Si is the SGPA of the i<sup>th</sup> semester and Ci is the total number of credits in that semester.

iii. The SGPA and CGPA shall be rounded off to 2 decimal places and reported in the transcripts.

# 28.4. Ranking and Awards of Scholarship/Prizes/Medals:

- a) Scholarship shall be awarded on the basis of semester performance (SGPA of the semester) and in case of equality of this SGPA, marks in theory papers shall be considered for award of scholarship.
- b) Gold Medal/Overall Rank shall be awarded on the basis of CGPA (Cumulative Grade Point Average), those candidates who appear and pass examination in all the papers of the four/six semesters at first emergence are eligible. In case of equality of this CGPA, the SGPA of last semester and then preceding semesters shall be considered.
- c) Only those candidates who appear and pass examination in all the papers of the four semesters at first emergence are eligible to be placed in the first class with distinction.
  - However, no candidate who has not passed all the papers relating to any semester at the first appearance are not eligible for any medals, or prizes by the college and to receive certificates of rank, obtained by them in the examination.

#### 29. Power to remove difficulties:

It any difficulty arises in giving effect to the provisions of these regulations, the Principal may by order make such provisions not inconsistent with the Act, statutes, Ordinances or other Regulations, as appears to be necessary or expedient to remove the difficulty. Every order made under this rule shall be subject to ratification by the Academic Council.

# 30. Grievance & Redressal Committee:

The College shall form a Grievance Redressal Committee for each course in each department with the Course Teacher and the HOD as the members. This Committee shall solve all grievances relating to the Internal Assessment marks of the students.

# 31. Award of Degree:

No student shall be eligible for the award of the degree unless he/she has successfully completed a programme, of not less than two or three year's duration (four/six semesters).

## 32. Repeal and Savings:

The existing Regulations governing three/two years UG & PG programmes in the faculties of Arts, Science, Commerce and Management shall stand repealed. However, the above Regulations shall continue to be in force for the students who have been admitted to the course before the enforcement of this regulation. The Academic Council reserves the right to alter or amend or repeal or annul any or all of the rules and regulations.
