## PROVISIONAL ALLOTMENT ORDER

This is to inform that the options exercised by the candidate have been processed based on rank, local area, sex, category, Special Reservation Category(CAP / PH / NCC / SPORTS) etc and the candidate has been allotted a seat in

The students belonging to SC/ST/BC/EBC/ Disabled/ Minority categories will be considered for Full Reimbursement of Tuition Fee (RTF) which is subject to verification and eligibility criteria prescribed by State Government of Andhra Pradesh vide G.O.MS.No:72 dated:18.10.2014 of social welfare department. In the event of the candidate found not eligible for fee reimbursement, the candidate shall have to pay the annual tuition fee. Those who are not eligible for reimbursement as prescribed in G.O.MS.No:72 dated:18.10.2014 shall pay annual tuition fee as existing for the college in the previous block period.

## Instructions to Candidates:

- 1. Report through 'Candidates Login' from website https://apicet.nic.in through a self-reporting system or from a nearby help line centre.
- 2. Take print out of two copies of allotment order and joining report and report to the allotted College. Submit a copy of allotment order and joining report and obtain acknowledgement on 2nd copy of joining report from the College where you have reported and retain with you.
- 3. Both Self reporting and reporting at the allotted College is compulsory to retain the present allotment. The last date for Self reporting and reporting at the allotted College is 28.08.2019
- 4. If you do not report through self-reporting system and/or not reporting at the allotted college, the provisional allotment will be treated as a vacancy for the subsequent phase and the provisional allotment of 1st phase will automatically stands cancelled and you have no claim on the seat allotted.
- 5. The academic credentials verified if found false at a later date, your allotment will be cancelled and you are also liable for criminal prosecution.
- 6. Candidate is not required to deposit original certificates in the college at the time of admission.

  The candidate can produce original certificates only for the purpose of verification in the college and can submit only Xerox copies in the college
- 7. Candidates who are not eligible for fee reimbursement shall pay the tuition fee after final phase only.

  College managements are instructed, not to collect any type of fee from the candidates till the final phase of admissions
- 8. Class work will commence from 29.08.2019.
